| 6. The delivery location <u>IS NOT</u> on a single lane dirt or gravel road, <u>DOES NOT</u> require crossing a wooden/uncertified bridge and <u>DOES NOT</u> require the use of tire chains. | | |
| 7. I understand that curb-side deliveries cannot be made without proper safeguards; (a) a minimum road width of 22'-0", a minimum clearance height or 13'-6" and a delivery area slope of <u>NOT more than 5 degrees.</u> | | |
| (a) Curbside deliveries made from a public road or highway will not be made unless the roadway is officially blocked or barricaded from all directions by local law enforcement or other traffic officials. It is your responsibility to make these arrangements and pay any required fees. | | |
| 8. I understand that the delivery driver has authority to refuse a job site delivery if the information I provide is inaccurate ^(b) or for safety and/or other legitimate reasons. | | |
| (b) Delivery fees are non-negotiable if you provide inaccurate information that causes the job-site delivery to be aborted, or if job-site conditions have changed such that delivery cannot be safely accomplished. Delay fees of \$100/hour (prorated after the first 1 hour) may be assessed. | | |
